<sup>1</sup> Rule 38 Nominations for election to the Executive Committee should normally be submitted to the General Secretary not less than 20 days, and **circulated to all FICSA Members not less than 15 days, before the opening of the Council session.** Should there be no nominations received prior to this deadline, nominations for the membership of the Executive Committee shall be submitted to the Chair of the Council session not less than 48 hours, and circulated to all delegations not less than 24 hours, before the elections are held. Each nomination shall be submitted in writing by the association/union to which the candidate belongs and shall be accompanied by a summary of the candidate's record as staff representative.
